



As per Regulation 15 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, the compliance with the Corporate Governance provisions specified in Regulations 17, 17A, 18, 19, 20, 21, 22, 23, 24, 24A, 25, 26, 27 and clauses (b) to (i) of sub-regulation (2) of Regulation 46 and para C, D and E of schedule V shall not apply to the following class of Companies:

- The listed companies having paid up equity share capital not exceeding Rs. 10 crore and net worth not exceeding Rs. 25 crore, as on the last day of the previous Financial Year;
- Companies whose equity share capital is listed exclusively on the SME Exchange.

The paid up equity share capital of the Shree Rajiv Lochan Oil Extraction Limited is Rs. 30,150,000/- and net worth is Rs. 48,342,280.36/- based on its audited financial statements for previous financial year ended on 31/03/2021. Accordingly, the Company falls in the ambit of aforesaid exemption (a).
